City Manager Cowger said that there were rumors attacking him personally regarding work that was done at his residence implying that he got special favors from a city employee and a sewer hauler. He presented his personal cancelled checks to the Council to show payment that he made to the city employee and sewer hauler for work done at his residence.

Comments from Audience

William Sparrow thanked the Council for bringing up the Salvation Army. He would like to see it move forward. Make every effort to get money. Talk to Jim Mathias.

James Jones said the Salvation Army building needed a good clean up. There are leaks on the front end of the building. Save Pocomoke Youth, Inc. (formerly Save the Youth) serve the good and not so good youth. They need guidance and be involved in positiveness.

Councilwoman Downing said there are health issues with the building. Lead paint, dead pigeons, asbestos; a lot of it is air-borne.

Lt. Hancock said that the accident on Thursday, June 28, 2018 on Rt. 13 South was not fatal. He apologizes to the City for the backups. Trooper 4 had to land in the middle of Rt. 13 South. Pocomoke City will have a community meeting on Tuesday, July 31, 2018 at the Pocomoke City Community Center, time 6p.m. to 8p.m. Topics discussed will be the opioid epidemic, Police K-9, safeguarding your property, and Somerset County's pilot program 'Citizen Police Academy'.

William Sparrow said that at the accident on Rt. 13 South, the Fire Department is to maintain the area of Trooper 4. They try to keep a zone around the area of the chopper.

Deborah Graves asked what could be done to the house next to her mother, 704 Fourth Street.

City Manager Cowger said that 704 Fourth Street is on the list of dilapidated houses that are being addressed.
